Consent

If Colne Valley Self Storage uses your personal information for any other purposes not set out in this agreement, or without us contacting you first, you will be given the opportunity to withhold or withdraw your consent.

How we use the information we have collected from you

Colne Valley Self Storage will use your personal information for a number of reasons, these include;

- Colne Valley Self Storage may contact you in regards to the service you have signed up for (e.g. updates on contract timeframes, changes to service or personal information)
- To update you on relevant offers or services we think will benefit you.
- As stated above, information gathered from IP addresses will be analysed to improve the service offered by www.colnevalleyselfstorage.co.uk.

We will not keep Personal Data longer than is necessary for the purpose or purposes for which it was collected. Once Personal Data is no longer required, we will take all reasonable steps to destroy and erase it.

How we protect customers' personal information

We use a secure server when collecting and registering customer details. The secure server encrypts the information you enter before sending it to us. All personal information is stored on one system (SpaceManager) which is backed up regularly. They have their own privacy statement in relation to The General Data Protection Regulation 2017. We strongly advise that you fully read their privacy policy.
